# TO ALL NEW STUDENTS

Welcome to Rutgers! The ISSS team is very happy that you have chosen to study at Rutgers and are pleased to welcome you through our virtual <u>International Student Orientation program</u>, or ISO, which is supported through the University's Learning Management System, Canvas. All new students should have already received access details and instructions to access the Rutgers Global - ISSS Orientation course at site through their Rutgers email, and all modules of our virtual ISO program will remain available to you on Canvas through the fall semester.

If you are in the US or are traveling to the U.S. for fall 2021, please make sure you follow all the steps outlined in our <u>Post-Arrival Guide</u> so that our staff can activate your SEVIS status in a timely manner. If you are enrolling in the fall semester from overseas, we will not activate your SEVIS status until you arrive in the U.S. for spring 2022 or later.

Due to current Student and Exchange Visitor Program (SEVP) <u>guidance</u>, please remember that all international students with an **initial SEVIS record** must enroll in at least one in-person or hybrid course this fall semester in order to <u>maintain legal status</u>. If you and your academic advisor determine that there are no in-person/hybrid courses available for you, please consult with an ISSS adviser by sending an email to <u>isss-students@global.rutgers.edu</u>.

# TO ALL CONTINUING STUDENTS

Whether you are back in New Brunswick or continuing your program from a remote location, we extend a virtual "welcome back"! While our office at 180 College Avenue has reopened, we are offering a blend of in-person and remote advising services. Please refer to the <u>ISSS Advising Services</u> webpage for more information. Rutgers Global - ISSS continues to provide all programs and services in alignment with the <u>university operating procedures</u>.

Please also note that all university units will be closed on Monday, September 6, 2021, in observance of Labor Day.

Due to current Student and Exchange Visitor Program (SEVP) <u>guidance</u>, you may maintain legal status even if you are studying entirely online in the US or abroad. Fall 2020 guidance is still currently in place for 2021.

Continuing students who were in active F or J status on March 9, 2020 when modifications for COVID-19 became effective are able to maintain their immigration status while studying entirely online in the US or abroad, provided they continue to be enrolled full-time and are making normal progress toward their degree. Remember, students in active SEVIS status, whether from inside the U.S. or abroad, must follow all rules to maintain legal status.

# IMPORTANT DEADLINES AND REMINDERS

# FALL 2021 INSURANCE WAIVER REQUEST AND ENROLLMENT DEADLINE IS TUESDAY, SEPTEMBER 21, 2021

All F-1 and J-1 students on Rutgers visa sponsorship are required to maintain <u>a minimum level</u> <u>of health insurance coverage</u> and are automatically charged this fee when they register for a particular semester for enrollment in the University's health insurance plan.

Returning/continuing F-1 and J-1 students on Rutgers' visa sponsorship who have insurance coverage other than the student insurance plan OR are living outside of the United States for the complete fall coverage term need to request a waiver of that insurance fee that is charged to your term bills by following the exemption request process <u>outlined on our website</u>.

For new/incoming students who will not be located in the United States, we have made special arrangements to waive the University's Student Health Insurance Plan Premium and the International Student Fee for the fall 2021 semester. If you are a new/incoming student and have not yet completed the Fall 2021 Plans survey in the RGlobal portal, please do so now.

# STUDENTS WITH A TA/GA APPOINTMENT

Students with full TA/GA appointments who are enrolled in benefits through University Human Resources DO NOT need to contact our office to request a waiver of the student health insurance premium. You only need to submit your enrollment paperwork through Human Resources and do not need to submit waiver documentation to our office. Once Human Resources processes your insurance enrollment paperwork we will receive your coverage information and process your waiver.

ALL OTHER F-1 AND J-1 STUDENTS MUST <u>EITHER</u> ENROLL OR WAIVE. For more details on either process, please review the information and instructions on our website.

# FALL 2021 REDUCED CREDIT/COURSE LOAD FORMS FOR STUDENTS WITH LESS THAN A FULL-TIME CREDIT LOAD - DEADLINE IS FRIDAY, SEPTEMBER 17, 2021

To maintain legal status, all F-1 and J-1 students must pursue a <u>full course of study</u> at all times. This means being registered for a full credit load. There are cases, however, in which regulations consider a student to be pursuing a full course of study even if he or she is NOT actually registered for a full credit load. For example, students who only need 1 or 2 classes to complete their program, or graduate students who have completed all coursework, but are still conducting thesis or dissertation research, may be considered pursuing a full course of study even if not registered for 9 credits.

If you are eligible for a <u>reduced credit load</u>, you should submit your e-form request no later than September 17, 2021 to ensure your academic official can respond and our office can approve it by the deadline of September 24, 2021. Failure to receive approval by this deadline may result in the loss of your legal status in the United States. The Reduced Credit/Course Load Form must be submitted through the <u>RGlobal</u> student services portal.

If you have already submitted a Reduced Credit Load E-form to ISSS for Fall 2021 and received an email acknowledging its receipt, it is being processed and there is no need to worry. An International Student Advisor will contact you with any questions or issues.

# **COVID-19 VACCINATION AND THE FALL 2021 TERM**

Vaccination documentation should be uploaded to the <u>Rutgers Student Immunization portal</u> (NetID and password are required). International students who were unable to upload their proof of vaccination by the university deadline of August 1 due to difficulties in getting vaccines outside the US, may do so after they arrive and get the vaccine. Please complete all other immunization requirements and submit proof of COVID-19 vaccination once you have received the vaccine. # **REMINDER: MANDATORY COVID-RELATED APPS**

My Campus Pass is a self-screening app that must be used by students, faculty, and staff each day when traveling to campus or entering a Rutgers building. To access My Campus Pass, log into <a href="mailto:my.rutgers.edu">my.rutgers.edu</a>. The second app, Rutgers Visitors Log, is available by logging into <a href="http://visitorlog.rutgers.edu">http://visitorlog.rutgers.edu</a>. Visitors and guests with a legitimate business purpose that cannot be accomplished remotely must be registered each day using this platform. Anyone with an active <a href="NetID">NetID</a> can enter a quest through the system.

# **BEWARE OF SCAMS**

We have been made aware of scams targeting unsuspecting international students and scholars. These scams have become increasingly sophisticated, oftentimes with an apparently

government phone number appearing on your caller ID, or the caller knowing a lot of your personal information. As is true anywhere in the world, there are people who attempt to take advantage of international students and scholars, but with a little knowledge you can learn how to identify a scam and avoid falling victim to the scheme.
