Timetables

Personalised timetables are generated for students in September 2025. The outline timetable will be available in June 2025.

General pre-requisites

Most degrees at City St George's are three years long. The module code tells you what level of experience degree students taking that module will have.

Level 1000 modules are introductory level, degree students taking these in Autumn 2025 will be entering university level study for the first time.

Level 2000 modules are taken by students with a background in the subject area, for example one or two successfully passed university level courses in the subject area or with transferable skills/knowledge. Our <u>UK and British Culture</u> modules are designed to be taken by students from a wide variety of academic backgrounds, but with transferable skills.

Level 3000 modules are taken by students who have extensive knowledge of the subject area. Degree students will be the equivalent of a US major in the subject and will be graduating in summer 2026.

We recommend that full-time study abroad students should be taking modules from their intended or declared majors at Level 2000 and 3000. Students wanting modules for general credit or interest should consider Level 1000 or our modules listed under UK and British Culture.

Credit

All courses on the Study Abroad Programme are worth 15 UK credits/ 7.5 ECTS, and most US universities award 4 US credits. A full load at City St George's is 60 credits, i.e. four modules.

Results and transcript

Students studying in Autumn 2025 would expect to receive their results and official transcript from mid-February 2026.
