- Deadlines will be honored only if the submitted application or petition is thoroughly and correctly completed, approved /signed wherever necessary by the appropriate individuals, properly documented, and bearing correct filing fees--all as per the Center for Global Services instructions that corresponds to that application/petition type.
- As government processing times vary, *Center for Global Services cannot guarantee that applications and petitions submitted will result in timely approvals by the appropriate government agencies.* Center for Global Services guarantees only that we will turn the application around within the following time frames:
  - **DS-2019 Requests: 2 weeks**
  - **H-1B petitions: 4 weeks**
  - **PERM applications: 2 months**
- Center for Global Services reserves the right to refuse a late application altogether (even with late fee payment) based on CGS backlog at the time of submission and/or if prospects for a timely government approval are nonexistent.
- For an initial DS-2019 request being submitted with a late fee, CGS may recommend a later DS-2019 start date than the date requested by the host department if the department's requested start date is unrealistic. In such cases, departments that choose NOT to follow Global Services' recommendation to amend the start date will later be charged an **additional \$40 fee** if it should turn out after all that CGS has to amend the start date in SEVIS in order to keep the scholar's record from being auto-inactivated by SEVIS.
