## MESSAGE FOR NEW AND CONTINUING STUDENTS

Welcome and Welcome Back to Rutgers! The Rutgers Global – International Student and Scholar Services office (ISSS) is thrilled to work with all new and continuing international students. ## CHECK-IN ON YOUR RGLOBAL ACCOUNT

All new students must complete the mandatory check-in as a legal requirement of your F-1 or J-1 status. Log into your <u>RGlobal</u> account to get started.

#### **ENROLLMENT REQUIREMENTS FOR ALL INTERNATIONAL STUDENTS**

As a reminder, F-1 and J-1 students are not permitted to count more than one online class or 3 credits toward a full course of study requirement. For more information, please refer to the <u>Full Course of Study Requirement</u> page.

## APPLYING FOR A SOCIAL SECURITY NUMBER

F-1 and J-1 students must have a job offer letter and/or work authorization to be eligible to apply for a Social Security Number (SSN). Eligible students must follow the detailed instructions on our <u>Social Security</u> webpage, under How to Apply for a Social Security number.

#### REDUCED CREDIT/COURSE LOAD - FALL 2024 DEADLINE IS WEDNESDAY, SEPTEMBER 25

To maintain legal status, all F-1 and J-1 students must pursue a <u>full course of study</u>. This means being registered for a full credit load (12 credits for undergraduates and 9 credits for graduate students). In specific circumstances, students may be eligible for a

<u>Reduced Credit/Course Load</u>. Please review the website for information about eligibility, and instructions to submit a "Reduced Credit/Course Load" form to ISSS using the <u>RGlobal portal</u>. You will need approval from our office for less than full-time enrollment in any semester. The form can be completed online and will require your graduate program director/academic dean's approval. The deadline for submitting the form is **Wednesday, September 25, 2024.** Remember that it takes 3-4 days to process the form after receipt, and we cannot guarantee timely processing of forms received after the deadline. This could mean loss of legal status. Please review our <u>Maintaining Legal Status</u> page for more information.

#### FALL 2024 INSURANCE WAIVER DEADLINE IS WEDNESDAY, SEPTEMBER 25

Students with full TA/GA appointments enrolled in benefits through University Human Resources DO NOT need to contact our office to request a student health insurance premium waiver. You only need to submit your enrollment paperwork through Human Resources at the start of your appointment and do not need to submit waiver documentation to our office. Once Human Resources processes your insurance enrollment paperwork, we will receive your coverage information, and we will process your waiver.

All other F-1 and J-1 students must either enroll in The Student Health Insurance Plan (SHIP) or Waive coverage. Full instructions for enrolling in SHIP or submitting a waiver can be found on our <u>health insurance webpage</u>.

#### **EMPLOYMENT WORKSHOPS FOR INTERNATIONAL STUDENTS**

ISSS hosts virtual Off-Campus Employment Chat Sessions via Zoom, which are an opportunity for students to drop in and discuss their CPT/OPT questions with an International Student Advisor and connect with other students who are also interested in off-campus employment. These sessions will begin Thursday, September 19, and will continue throughout the Fall. Please view the full schedule on our website <u>here</u>.

ISSS hosts in-person CPT/OPT 101 workshops each semester for students to learn about the CPT and OPT process, eligibility, which forms to fill out with RGlobal, procedures, important dates, and filing your OPT application with USCIS.
