

PLEASE READ FULLY and CAREFULLY.

Disregard the deposit information on the previous screen. The deposit information for the ROSE program is listed below.

The Spring 2022 deposit will be a combination of a \$5,500 program fee deposit and a \$1,500 program fee deposit, for a total combined \$7,000. When paying, students will only have to pay one \$7,000 deposit. If a student applies and is granted a housing waiver, they only have to pay \$5,500. If a student withdraws, the below policies and refunds are in effect.

PROGRAM FEE DEPOSIT INFORMATION

- This \$5,500 deposit* is due Nov 19th, 2021 as part of the total \$7,000 deposit.
- *If you will have trouble making this payment by Nov 19th, then please email a ROSE Advisor at rose@global.rutgers.edu.
- Your participation in the ROSE program cannot be guaranteed without a paid deposit.
- This \$5,500 program deposit will be applied to your Rutgers Spring 2022 term bill if you enroll into the ROSE program. The deposit will reflect as a payment towards the overall bill.

- If withdrawing from ROSE before Jan 18th to attend Spring 2022 classes in New Jersey or fully online Rutgers classes, your deposit will be transferred to your term bill. If withdrawing from the University or not enrolling into Rutgers 2022 course options, the deposit will not be refunded nor transferred to your term bill.

HOUSING DEPOSIT INFORMATION

- The \$1,500 housing deposit fee is required for students who are staying at ROSE housing options and is included in the total \$7,000 deposit. Students who are granted a waiver to commute will only need to pay \$5,500.

- This deposit* is due Nov 19th, 2021.
- The \$1,500 portion of the deposit will be **non-refundable** after Dec 18th, 2021.

- *If you will have trouble making this payment by Nov 19th, then please email a ROSE Advisor at rose@global.rutgers.edu.
- Your housing assignment in campus housing or hotels cannot be reserved for you without a paid deposit.
- Your housing deposit will be applied directly to your term bill. The full amount of the housing bill will be paid by the student directly to the hotel upon check-in.

- If ROSE housing is no longer available due to full capacity, you will be notified through email. If you had already paid a deposit, your deposit will be refunded in full or applied to your term bill in full.

- If a student withdraws from housing after July 15st, 2021, they will be required to pay a cancellation fee. The cancellation fee will be charged according to the following schedule:

- (a) Full Refund: Deposit will be returned and no additional fees charged (December 18, 2021 and before).

- (b) 25% Cancellation Fee: If written notification of withdrawal of (a) confirmed participant(s) between (December 19, 2021 – January 18, 2022), students will be charged a cancellation fee of 25% of housing total (deposit is part of 25%).

- (c) 50% Cancellation Fee: If written notification of withdrawal of (a) confirmed participant(s) between (January 19 – February 1, 2022), students will be charged a cancellation fee of 50% of housing total (deposit is part of 50%).
- (d) 75% Cancellation Fee: If written notification of withdrawal of (a) confirmed participant(s) between (February 2 – February 18, 2022), students will be charged a cancellation fee of 75% of housing total (deposit is part of 75%).
- (e) Withdrawal After Student Arrival Date: No housing refund for any withdrawal on or after the student arrival date will be given. (February 19, 2022).

PAYMENT

- Payments must be made through the online payment portal link found in your ROSE application materials. Please use your own credit card. If you use a parent or family member's card, please remember the name and details of that account. with their own credit card.

- When you click on the Pay Now button, you will be taken to the online payment system. Upon successful submission of your payment, a confirmation screen will appear.

Navigate back to your ROSE application portal, and you will find a check mark in the Program Deposit box. You will also receive a confirmation email from the payment processing website. Please save this email as it is your receipt.

- Credit cards accepted include: American Express, Discover, MasterCard, or Visa.

- If after 1-2 business days (Monday-Friday, 8.30a - 5p EST), your deposit is still unmarked but your payment was successful, please send us an email for us to manually verify.

PARTICIPANT ACKNOWLEDGEMENT

By committing to this ROSE program, I acknowledge and agree to the following:

1. Participation Agreement: I have read the ROSE Participation Agreement in its entirety and fully understand my responsibilities. I have had an opportunity to ask questions. I understand its terms and I agree to the terms stated.

2. Deposit: My program deposit is non refundable, should I choose to withdraw from Rutgers for any reason after Dec 18th, 2021. I understand that deposits will be applied to my term bill if attending ROSE or withdrawing from ROSE for attending Spring 2022 courses in NJ or online. By paying this deposit, I fully intend to participate in the program, and will be treated as such by Rutgers Global and ROSE staff.

3. Withdrawal Policy: I have read the Withdrawal Policy, understand its terms, and I agree to the terms stated. Additionally, I understand it is my responsibility to notify the ROSE staff by using the appropriate withdrawal form if I am no longer able or willing to participate in this ROSE program before January 18th, 2021. No other written or oral communication will be accepted in lieu of the official form. I am fully aware that the program withdrawal policy is different from the housing withdrawal. Note: There may be financial implications associated with my withdrawal. I have read and understand the timeline set forth by Rutgers by the Rutgers Global and ROSE staff.

4. Financial Obligation: Estimations of program costs, also known as or billable costs (as shown on the ROSE program web pages,) will be reflected on my Rutgers Student Term Bill. I understand these amounts may fluctuate based upon my school of enrollment and are set forth by Rutgers Student Accounting. I am responsible to pay my term bill based on the terms, conditions, and deadlines set forth by Rutgers Student Accounting. Non-billable

charges, such as airline costs, travel documents, meals, personal expenses, and other travel are out of pocket expenses that I must pay on my own with no assistance from Rutgers University. I understand that I need to have the financial resources to cover the aforementioned such costs and any unforeseen fees associated with my participation in ROSE.
